2. E- Auction Date & Time: 20<sup>th</sup> August 2021 from 3.00 p.m. to 5.00 p.m. (with unlimited extensions of 5 minutes each and minimum incremental bid of INR10,00,000).
3. Bidders needs to bid for all the vessels in a respective block. Bids for individual vessels is not permitted. Bidder can bid for multiple blocks.
